Dear Parent/Carer,

RE: Exams Summer Awarding 2021 – Teacher Assessed Grades (TAG) for GCSE & some Entry Level Qualifications

As you will be aware, government guidance released earlier this year stated that students will be awarded grades that are determined by teachers based on a range of evidence including students completing questions provided by the exam boards. We will be submitting grades based on evidence to exam boards by 18 June 2021.

To ensure that you and your child are fully informed, all of our policies and procedures are in line with guidance and training released from the Department for Education, Ofqual, the Joint Council for Qualifications (JCQ) and awarding organisations. Centre Policy

All schools are required to submit a centre policy outlining the process in detail to the awarding organisations so to support parental communication you can find Wilson Stuart School Centre Policy on the **“Exams Summer Awarding 2021”** section of our website. Please note that all school’s centre policies are externally moderated by exam boards.

How will students be assessed?

Teachers will determine students’ grades based on what they have been taught and teachers can use a range of evidence from across the course of study to make their decision. Teachers can assess students based on:

- records of performance on the content that they have been taught over the entire course of their studies.
- non-exam assessment, often referred to as coursework or internal assessments, even if they have not fully completed it.
- work they have produced for tasks set by the school that reflects the specification, format and marking of exam boards.

In most cases the range of evidence that teachers will use to inform students’ grades will be consistent across a class or cohort for each qualification. Teachers have been briefed on the principles of fairness, objectivity, and equalities and disabilities legislation. It is important to note that no single piece of evidence will necessarily be more important than another, as teachers will be completing the assessment process based on a range of evidence that can give an overall picture of each students’ performance.

For qualifications Ofqual and the Department of Education have deemed not in scope for a Teacher Assessed Grade (Some Entry Level qualifications, Functional Skills & Vocational qualifications), these

qualifications will continue as normal and will be externally moderated for a grade to be determined. The majority of the qualifications under this category have either a reduced assessment or adaptations to ensure that students will still receive a grade this Summer.

Further guidance on which qualifications are award a TAG or will continue as normal can be found on our website under “Exams Summer Awarding 2021”.

What evidence will be used?

As previously communicated, following the students return to school earlier this year, they have been engaging in evidence collection activities to provide their teachers with recent evidence which will be used as part of the grading process in line with JCQ guidance. Students have been informed that this evidence will form the basis of their grades and teachers have endeavoured to ensure that the evidence is consistent for all students studying a particular subject. This evidence covers areas of the specification that has been taught and gives all students an opportunity to demonstrate their skills, knowledge and understanding.

Part of our role is to inform each student of the evidence we are using to support the grading process and students have been informed that the recent evidence collection activities will form part of the grading process.

Reasonable adjustments and access arrangements

If your child has special educational needs, and/or is disabled, and requires reasonable adjustments, the academy will make every effort to ensure that these were in place when evidence was gathered and that students are informed of this adjustment. If for some reason appropriate reasonable adjustments were not in place when your child took an assessment that is being used as evidence, the teacher will take that into account when determining your child’s grade. In all evidence collection activities that have taken place since the students return, all students who required reasonable adjustments were given these.

Mitigating Circumstances and Special Considerations

Special consideration requests will not apply in the usual way this summer because your child will not be taking exams. In line with government guidance, we will be providing each student with an opportunity to raise any mitigating circumstances regarding a specific piece of evidence.

How will grades be determined?

Teachers will use the evidence to objectively and fairly assign a grade using grading descriptors and exemplars provided by the exam board. Teachers have received training on this process in line with guidance from the Department for Education, Ofqual, the Joint Council for Qualifications (JCQ) and awarding organisations.

Teachers have also received training on objectivity and bias with a robust process of moderation and standardisation in place to ensure that grades are awarded fairly. Grading decisions will be holistic judgments, considering all of the evidence as a whole. Once a teacher has determined a student's grade, it will be reviewed by other teachers, so grades are determined consistently and in line with the school policy.

When will grades be released?

Grades will be released on results days this year, dates for which are listed below. Due to the uncertainty regarding Covid regulations we intend to operate results days by appointment slots where students/parents can safely access their results and support/guidance with relevant key staff. Details regarding this will be sent to you in due course.

- GCSE and some ELC students will receive their results on **Thursday 12 August 2021**.

Under government guidance we are not allowed to release information regarding these grades before this date and we must also confirm that judgements have not been influenced by pressure from students or parents/carers. I would therefore like to ask you and your child to not enquire or pressure teachers to provide these grades before those dates.

Appeals

Having followed the guidance from the Joint Council for Qualifications as outlined, we are confident that students will be awarded the correct grades based on their knowledge, skills and understanding on the dates outlined above. As a safety net we have put in place an appeals procedure to fix any genuine errors, details of **which can be found on our website under the heading "Exams Summer Awarding 2021"**

We will continue to work tirelessly to support students and endeavour to ensure they are not disadvantaged by the grading processes in place this year.
